LETTERS TO A KING.

O say that this latest work of the author of "A Fool's Errand" is strikingly original both in form and matter, is simply to emphasize the fact of its authorship. Like almost all his works, it is of a political character; but it covers a field of thought which no writer has hitherto attempted to treat as a whole. In a manner singularly simple and direct, yet comprehensive and impassioned, the author discusses the relations of the individual citizen to the direction and control of government in a republic.

The treatment is in the form of a series of

letters to a young man who has just attained his twenty-first birthday. The book is dedicated to "the sons of those who died that the Republic might live." It is the work of a jurist, a politician, a patriot, and a Christian philosopher, colored by the dramatic instincts of the novelist, and done with the skill of the accomplished man of letters. Every page glows with the fire of a fervid patriotism, but there is not a hint of partisanship in the entire book. The style is so lucid, and the writer's method so unpretending, that one hardly realizes how much ground has been covered, and how great the range of subjects discussed, until the end of the volume is reached and a brief summary of conclusions confronts the surprised reader. Many readers may feel the smart of the author's caustic words, but few will question his premises or doubt his conclusions.

Very few have ever comprehended the real difference between "subject" and "citizen," or the actual identity between the political duty of the citizen and the responsibility for good government that rests upon a king. Not the most profound among our states-

men understand as thoroughly as they will after reading the author's elucidation, the philosophy of the American party system, the history of its development and its true relations to a republican form of government. No "practical politician" has made so clear the theory of party allegiance; no champion of independence in politics has so carefully traced the line of responsibility and duty for the political dissident; and no teacher of Christian ethics has so forcibly illustrated the intimate connection between political privilege and religious duty.

It is a book which every statesman and politician will read with interest and advantage; which no student of political methods can afford to neglect; which no teacher of religious duty should fail to study, and which no one who desires to understand and perform his duty as a Christian and a citizen should fail to become thoroughly familiar with.

In his exposure of corrupt methods, the causes and delineation of their effects, Judge Tourgée is as unsparing as Ezekiel. The instances he adduces, though drawn from

real life, are universal in their application, and the remedies he proposes have the merit of such simplicity as to make them seem absolutely original. The work is very properly entitled "Letters to a King." It is not a mere manual of political history nor a guide-book of civic duty, but a graphic, lucid, and comprehensive explication of the duties incumbent on the citizen as a ruler, how they may be effectually performed, and the consequences of their neglect.

No young American should be allowed to pass his twenty-first birthday without this volume being placed in his hands.
