The nation will soon be composed of millionaires and paupers, such as is noticed in despotisms of Europe and Asia. Failures now reported in the United States amounts to over 14,000 annually, to say nothing of the hundreds of thousands of forced sales of homes and business men who are quitting business. This conditions of things must have an end. The American people will never be satisfied to have their children reduced to serfdom. Have you ever given the problem any thought? Do you believe that all the philosophers and students who have investigated these questions are fools and know nothing, while the people who have not investigated know all about it? And what have you ever read on the rights of mankind regarding the ownership or use of land? or the railroads? You may deceive yourself, but if you do it will cost your children, who are not able to defend their rights, many groans and much agony. These are live questions which the progress of the world is forcing to a solution. There will be great social changes in the near future. Are you willing to remain ignorant of the great forces now at work undermining the present conditions of society?
